

Bitcoin20X (\$BTC20X) - Terms of Service

Effective Date: August 17, 2023

These Terms of Service ("Terms") govern your use of btc20x.com and related services. By accessing or using btc20x.com, you agree to comply with and be bound by these Terms. If you do not agree with any part of these Terms, please do not use btc20x.com.

1. Acceptance of Terms

These Terms constitute a legally binding agreement between you and btc20x.com. btc20x.com is a website hosted by Cloudflare and Whoisprotection is used for website protection.
